## **Tower Certifies 3 Million Square Feet Under Fitwel Viral Response Module**

The Tower Companies prioritizes occupant health as the first commercial real estate owner and manager to implement the Fitwel Viral Response module across its entire managed portfolio of commercial office and multifamily buildings

**Rockville, MD –** The Tower Companies (Tower), a Washington, D.C.-based real estate developer and recognized sustainability leader, announced today that it has implemented the Fitwel Viral Response (VR) module across its entire portfolio of commercial office and multifamily properties. After being <u>among the first to certify its corporate policies</u> under the VR module and the first globally to secure asset-level approval, Tower quickly applied the program across its 3 million-square-foot portfolio.

Fitwel is the world's leading certification system committed to building health for all™. Originally created by the U.S. Centers for Disease Control and Prevention (CDC) and U.S. General Services Administration, Fitwel is a rigorous, third-party healthy building certification system operated by the Center for Active Design (CfAD) that sets the industry standard for evidence-based strategies to promote positive health outcomes for building occupants and communities.

The VR module was intentionally designed to offer property owners the flexibility to establish effective viral mitigation protocols for commercial and residential asset types. Unlike other solutions, Fitwel's VR module has established best practices for companies to follow by setting minimum requirements that are necessary to mitigate viral transmission, while providing turnkey policies to ensure an efficient and consistent approach to guide the industry.

"We applaud The Tower Companies for its leadership in the healthy building movement as one of the first to achieve Fitwel Viral Response approval across its 3 million square-foot portfolio of commercial and residential assets," said Joanna Frank, President and



CEO of CfAD. "By implementing the module's strategies and best practices portfoliowide, Tower has demonstrated its commitment to creating safer environments for occupants and residents that mitigate risk of viral transmission and promote health and wellness throughout."

The VR module is scored out of 100% with anything over 90% earning a special distinction. Tower scored 91%, which represents 18 unique viral mitigation strategies that enhance indoor environments, encourage behavioral change and build occupant trust. For example, Tower implemented a robust indoor air quality policy that mandates strict preventative maintenance procedures, high-efficiency filters, UVC lighting and indoor air quality monitoring to provide optimal conditions for building occupants. Beyond many operational strategies, Tower also adapted health programming for its clients and residents to encourage healthy living whether they are at home or the office, which includes free weekly virtual fitness classes and other wellness events.

"Our COVID-19 response is like a symphony. Each instrument—in this case, each strategy—plays a crucial role in our layered and robust approach. Whether it's enhanced operational protocols or UVC lighting, no one measure is sufficient on its own when dealing with airborne viruses and new variants as they arise inside buildings," said Jeffrey Abramson, partner at The Tower Companies. "At the heart of our response is our genuine care for our tenants' and employees' health and wellbeing, and our desire to encourage the industry to meet the needs of today and rise to the expectations of tomorrow. The Fitwel Certification System continues to provide the resources to make this a reality."
